Retention of Undergraduate Students Fall 2023 to Spring 2024

This study tracks 14,752 undergraduate students classified as freshman, sophomore, junior, or senior who were enrolled in Fall 2023. In this report, first-time freshmen and new undergraduate transfer students who initially enrolled in Summer 2023 and continued in the fall term were classified as entering students and are included in the population. Students classified as non-degree seeking or post-baccalaureate are excluded from this study. Retention figures for Fall 2023 to Spring 2024 are compared to the retention figures for Fall 2022 to Spring 2023, as follows:

- a. Of the 14,752 undergraduate students enrolled in Fall 2023: 647 (4.3%) graduated in December 2023, 13,703 (92.9%) enrolled in Spring 2024, and 402 (2.7%) did not reenroll. Adjusting for graduates, the retention rate was 97.1% (13,703 / 14,105). Refer to Section 1 for more detail.
- b. Of the 3,317 first-time freshmen enrolled in Fall 2023: 3,224 (97.2%) enrolled in Spring 2024, and 93 (2.8%) did not reenroll. Refer to Section 2 for more detail.
- c. Of the 314 new undergraduate transfer students enrolled in Fall 2023: 292 (93.0%) enrolled in Spring 2024, and 22 (7.0%) did not reenroll. Refer to Section 3 for more detail.

The retention rate for Fall 2023 undergraduate, first-time freshman and new transfer student cohort groups increased from the previous year’s rate. Female students retained at a higher rate than their counterparts for all three cohort groups. In all categories, first generation college students retained at a lower rate than their counterparts. First-time freshmen and new transfer students who attended a line camp retained at a higher rate than those who did not attend line camp. The majority of new transfer students came to Baylor from 2-year institutions (56.4%). Those transferring from 4-year institutions, however, retained at a higher rate than those from 2-year institutions, 96.0% compared to 90.4%.

In the following tables, enrollment, attrition, and graduation rates are listed based on the students’ status at the *beginning* of the Spring semester. The reader is reminded that the attrition statistics include those students who completely withdrew from school as well as those who elected to enroll at other postsecondary institutions.
